On March 16, 2016, the Warren County Grand Jury returned an indictment against the above named individual. This indictment includes thirteen counts and charges:

- Three counts of Aggravated Sexual Assault [victim under thirteen (13) years old], first degree;
- One count of Aggravated Sexual Assault [victim at least thirteen (13) but less than sixteen (16)], first degree;
- Three counts of Sexual Assault [victim under thirteen (13) years old], second degree;
- One count of Aggravated Criminal Sexual Contact, third degree;
- Four counts of Endangering the Welfare of a Child, second degree;
- and
- One count of Child Abuse/Neglect, fourth degree.

The Indictment alleges that the defendant committed multiple acts of sexual penetration, specifically digital penetration, upon a child under thirteen (13) years old and continued the acts after the child was at least thirteen (13) but not more than sixteen (16) years of age. The child in question was known to the defendant. These crimes occurred in Washington Boro, Oxford, Washington Township and Allamuchy, Warren County, respectively.

Aggravated Sexual Assault where the victim is under thirteen (13) years old is a First Degree Crime punishable by up to life imprisonment. Aggravated Sexual Assault where the victim is over thirteen (13) but less than sixteen (16) years old is a First Degree Crime punishable by up to twenty (20) years New Jersey State Prison. Sexual Assault is a Second Degree Crime punishable by up to ten (10) years New Jersey State Prison. Endangering the Welfare of a Child is a Second Degree Crime punishable by up to ten (10) years in New Jersey State Prison. Aggravated Sexual Contact is a Third Degree Crime punishable by up to five (5) years New Jersey State Prison. Child Abuse/Neglect is a Fourth Degree Crime punishable by up to eighteen (18) months New Jersey State Prison.


The defendant is released on \$50,000 cash bail with conditions.

The Warren County Prosecutor's Office Special Victims Unit along with the New Jersey State Police conducted the investigation.

Please be advised that all of the charges are merely accusations and that the defendant is presumed innocent until or unless proven guilty.
