On May 26, 2017, the Phillipsburg Police Department, New Jersey State Police, the Warren County Prosecutor's Office Narcotics Unit, Warren County Hazardous Material Unit, and the Warren County Tactical Response Team executed a narcotics search warrant at 948 Mill Street, Phillipsburg, New Jersey, following a month-long investigation into the trafficking of methamphetamine in the Phillipsburg area. Methamphetamine, marijuana, paraphernalia and packaging, as well as items commonly used to manufacture methamphetamine were seized. The following people were charged:

Darren Ader is charged with:

1. One (1) count of possession of methamphetamine, a third degree offense in violation of N.J.S.A. 10a(1), and
2. One (1) count of possession with the intent to distribute methamphetamine, a third degree offense, in violation of N.J.S.A. 35-5b(9).

Nikolas Sember is charged with:

1. Two (2) counts of conspiring to distribute a controlled dangerous substance, to wit methamphetamine, a third degree crime offense in violation of N.J.S.A. 2C:5-2a(1)/2C:35-5b(9)(b), and
2. One (1) count of possession of methamphetamine, a third degree offense in violation of N.J.S.A. 10a(1).

Claudia Nething is charged with:

1. One (1) count of possession of methamphetamine, a third degree offense in violation of N.J.S.A. 10a(1), and
2. One (1) count of possession with the intent to distribute methamphetamine, a third degree offense, in violation of N.J.S.A. 35-5b(9).

Devin McCabe is charged with:


1. One (1) count of possession of methamphetamine, a third degree offense in violation of N.J.S.A. 10a(1).

Mark Varga is charged with:

1. Two (2) counts of possession of methamphetamine, a third degree offense in violation of N.J.S.A. 10a(1), and
2. Two (2) counts of possession with the intent to distribute methamphetamine, a third degree offense, in violation of N.J.S.A. 35-5b(9).

Each third degree offense carries a maximum term of imprisonment of five years and/or a fine of \$35,000 for possession and \$75,000 for distribution or possession with the intent to distribute a controlled dangerous substance.

Please be advised that all defendants are presumed innocent until proven guilty.
